- 9. Upon the occurrence of such a situation or event, the services shall be deemed to be postponed for a period of time equal to the delay caused by the Force Majeure and a reasonable period not exceeding two weeks.
- Claims for Default: Any claims for damages arising out of default and termination, shall be agreed between JPC and the Consultant, or failing agreement, shall be referred to arbitration in accordance with clause 20.
- Rights and Liabilities of Parties: Termination of this appointment for whatever reason shall not prejudice or affect the accrued rights or claims and liabilities of either party to this appointment.
- Confidentiality: The consultant shall maintain all information relating to the appointment in the strictest confidence.
- 13. Indemnity: The consultant indemnifies JPC and holds JPC harmless against any loss or damage that may be suffered by JPC (including and without ilmiting the generality of the aforagoing any claim that may be brought or threatened against JPC by any third party) arising from or by reason of the failure by the consultant to comply with its obligation in terms hereof.
